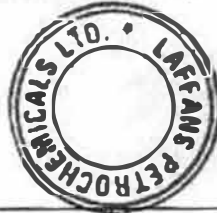

To the Board of Directors of Laffans Petrochemicals Limited,

1. 
